Minutes State Election Commission Meeting April 5, 2021

The State Election Commission meeting was called to order by Chairman Donna Barrett at 12:06 p.m., Central Daylight Time, April 5, 2021.

The following members and staff were present: Chairman Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; Coordinator of Elections Mark Goins and Kathy Summers, Elections Specialist.

Chairman Barrett added a public comments section to the agenda without objection due the request of several individuals in the audience wishing to speak. The commission went into recess for public comments.

- **Matt Jones** Mr. Jones is the Republican Party Chairman for Benton County. Mr. Jones spoke in favor of their Administrator of Elections and requests the commission reappoint the current Republican members of the county election commission.
- **James Peach** Mr. Peach of Benton County spoke on the behalf of Mark Ward. Mr. Peach helped Mr. Ward obtain the position of Administrator of Elections in 2009 and is in favor of the current county election commissioners being reappointed. Mr. Peach asked if any State Election Commissioners had a conflict of interest in dealings with Benton County.

The commission came out of recess and Chairman Barrett addressed Mr. Peach's statement regarding conflict of interests. Chairman Barrett advised under state law, state election commission members are required to file annual conflict of interest disclosure statements. Chairman Barrett annually discloses her company, The Barrett Group, which provides services to multiple small businesses across the state and to twelve (12) counties in Tennessee. Benton County is one of the counties her company serves.

The commission went back into recess for public comments.

• Representative Bruce Griffey – Representative Griffey spoke in support of the current Benton County Election Commission and requested current members be reappointed.

Commissioner Younce made a motion to adopt the January 11, 2021, minutes seconded by Commissioner Duckett. (Aye votes: Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.)

Commissioner McDonald made a motion to adopt the January 28, 2021, telephonic minutes seconded by Commissioner Blackburn. (Aye votes: Barrett, Blackburn,

Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.)

Commissioner Wheeler made a motion pursuant to TCA. § § 2-12-101 and 2-12-106 to approve any nomination(s) for county election commission appointments submitted, and to leave the nomination process open until 4:30 p.m. Central Daylight Time, Monday, April 5, 2021, seconded by Commissioner Younce. (Aye votes: Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.) (See attached county election commission appointments made.)

• Discuss Letter from Williamson County Regarding Voting Machines (See attached letter from Williamson County.)

Chairman Barrett requested Coordinator Goins to lead the discussion on the letter received from Williamson County Election Commission.

Coordinator Goins advised Williamson County would like for the State Election Commission to review the Dominion Voting System. All voting machines were last reviewed by the State Election Commission in 2015, and the next time machines are up for review would be in 2023. Coordinator Goins suggested if the commission were to review Dominion's voting system, they might want to review all machines at the same time.

Commissioner Wheeler made a motion to review all voting machines, seconded by Commissioner Younce. (Aye votes: Barrett, Blackburn, Duckett, McDonald, Wheeler, Wallace and Younce; No votes: None; Abstention: None.)

Chairman Barrett named the following members to serve on an ad hoc committee to review voting machines.

A motion was made by Commissioner Wallace and seconded by Commissioner Younce to elect Judy Blackburn as Chairman of the State Election Commission. (Aye votes: Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.)

• Election of Secretary for the term of May 1, 2021 through April 30, 2022 A motion was made by Commissioner McDonald and seconded by Commissioner Blackburn to elect Tom Wheeler as Secretary of the State Election Commission.

(Aye votes: Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.)

• Discuss Moving the April 12, 2021, Meeting

A motion was made by Commissioner Younce to move the April 12, 2021, meeting to July 12, 2021, seconded by Commissioner Blackburn. (Aye votes: Barrett, Blackburn, Duckett, McDonald, Wallace, Wheeler and Younce; No votes: None; Abstention: None.)

Coordinator Update

Legislative Update - Coordinator Goins does not expect a lot of legislative changes this year.

TACEO Seminar - Coordinator Goins advised commissioners the annual training will be held virtually in September. The reason for conducting the seminar later is due to the delay in obtaining Census information and Administrators will be trained on how to handle Census data.

Coordinator Goins handed out employee signed "Stop Here. Wait Here." election decals used in the 2020 election cycle, to show appreciation of the support given to the Division of Elections by the State Election Commission.

Commissioner McDonald asked Coordinator Goins about the legislation filed requiring voters to provide their fingerprints. Coordinator Goins stated this legislation, by Representative Lynn and Senator Nicely, would be voluntarily by the voter but he does not see this bill passing due to administrative costs.

The meeting was adjourned at 12:40 p.m. Central Time.

The next scheduled meeting is set for July 12, 2021 and will be held in the William R. Snodgrass – Tennessee Tower, Nashville Room - 3rd floor at 12:00 Noon, Central Standard Time.

EXECUTIVE ORDER

BY THE GOVERNOR

No. 78

AN ORDER EXTENDING REMOTE MEETINGS AND IMPLEMENTING BEST PRACTICES ACROSS THE STATE TO PROMOTE TRANSPARENT GOVERNMENT BY EXTENDING EXECUTIVE ORDER NO. 71, AS AMENDED

WHEREAS, on March 20, 2020, I issued Executive Order No. 16, which allowed governing bodies to meet electronically regarding essential business in light of COVID-19, and that order was extended by Executive Order Nos. 34, 51, 60, 65, and 71; and

WHEREAS, the effects of COVID-19 continue to affect our citizens, and it is imperative to ensure that gatherings are conducted in a transparent and safe way, particularly for those at increased risk of suffering severe illness from COVID-19; and

WHEREAS, certain best practices have emerged across the state as a result of months of experience with conducting with electronic meetings during the COVID-19 pandemic, and all governing bodies were required to transition to such best practices on October 1, 2020, which are restated below for clarity; and

WHEREAS, the suspension of selected state laws and rules and the other measures contained herein are necessary to facilitate the response to the current emergency.

NOW THEREFORE, I, Bill Lee, Governor of the State of Tennessee, by virtue of the power and authority vested in me by the Tennessee Constitution and other applicable law, do hereby declare a continuing state of emergency to facilitate the response to COVID-19 and order the extension of the provisions of Executive Order No. 71, as amended herein, and more specifically order the following:

Meetings of governing bodies.

As a reasonable measure to protect the safety and welfare of Tennesseans while ensuring that government business may continue in a manner that is open and accessible to the public, the provisions of Tennessee Code Annotated, Title 8, Chapter 44, Part 1, are hereby suspended to the extent necessary to allow a governing body, as defined in Tennessee Code Annotated, Section 8-44-102, to meet and conduct its

essential business by electronic means as provided for herein, rather than being required to gather a quorum of members physically present at the same location, if the governing body determines that meeting electronically is necessary to protect the health, safety, and welfare of Tennesseans in light of the COVID-19 outbreak, subject to the following conditions:

- a. All meetings of a governing body conducted by electronic means under this Order shall remain open and accessible to the public by providing real-time, live audio or video access to the public; provided, that in the case of contested case hearings under title 4, chapter 5, part 3, this requirement may be satisfied through compliance with Tennessee Code Annotated, Section 4-5-312(d); and
- b. A clear audio or video recording of the meeting shall be made available to the public as soon as practicable following the meeting, and in no event more than two (2) business days after the meeting; and
- c. In the public notice required by Tennessee Code Annotated, Section 8-44-103, governing bodies shall provide information regarding how the public can obtain real-time, live access to or broadcast of the meeting, and governing bodies are strongly urged to provide an agenda for the meeting in such notice; and
- d. Members of governing bodies, staff, and others participating in an electronic meeting by audio means only shall identify themselves in a manner reasonably calculated to permit the public to ascertain the identity of the person speaking; and
- e. This Order does not in any way limit quorum, meeting notice, or voting requirements under current law; and
- f. This Order does not limit, preempt, or repeal any local requirement permitting public comment during meetings, except that compliance with such requirements may be accomplished by allowing timely and appropriately submitted written public comments to be read into the recordby a member or staff of the governing body during the meeting of the governing body; and
- g. The provisions of Tennessee Code Annotated, Section 8-44-108(c), apply to all state and local governing bodies; and
- h. All such meetings shall be conducted in a manner consistent with Article I, Section 19 of the Tennessee Constitution.

- 2. Pursuant to Tennessee Code Annotated, Sections 58-2-107 and 58-2-118, I hereby authorize all governing bodies, state departments and agencies, and political subdivisions of the state, and other agencies designated or appointed by the governor to make, amend, and rescind orders and rules as necessary to conduct electronic meetings as provided for herein and adhering to the provisions and spirit of the Tennessee Constitution and Open Meetings Act.
- 3. Given the findings underlying, and general applicability of, this Order, Tennessee Code Annotated, Section 8-44-108(b)(3), which requires each governing body to provide findings to the Secretary of State concerning the need for a meeting where a quorum is not physically present, is hereby suspended.
- 4. Nothing in Paragraph A.1 prohibits some members of a governing body from participating in a meeting of the governing body in the same physical location while another member or members participate in the meeting electronically, so long as the governing body complies with all of the conditions and requirements of Paragraph A.1 with respect to that meeting.
- 5. The provisions of Tennessee Code Annotated, Section 4-5-312(c), are hereby suspended to the extent necessary to allow contested case hearings to proceed by telephone, television, or other electronic means, in the discretion of the administrative law judge or hearing officer and agency members, regardless of whether the parties agree. This paragraph does not waive the requirement that each participant in the hearing have an opportunity to participate in, to hear, and, if technically feasible, to see the entire proceedings while taking place.

AA. Remote Shareholder Meetings

- 1. Tennessee Code Annotated, Section 48-17-109, which requires shareholders participating in a meeting conducted through special communications be able to simultaneously hear each other during the meeting, is hereby suspended; provided, that the corporation or its board of directors establishes procedures to enable verified shareholders and proxyholders not physically present at the meeting with a reasonably opportunity to:
 - a. Read or hear the proceedings of the meeting substantially concurrently with such proceedings;
 - b. Submit questions during the meeting;
 - c. Be deemed present in person at the meeting; and
 - d. Vote on matters submitted at the meeting.

- 2. Tennessee Code Annotated, Section 48-17-101(b), is hereby suspended to the extent necessary so that the place of meeting required to be specified may include a method of remote communication in which shareholders may participate in accordance with Paragraph AA.1.
- 3. The relevant provisions of Tennessee Code Annotated, Section 48-17-201(c), requiring that a corporation holding a shareholders' meeting make available at the meeting its list of shareholders who are entitled to notice of a shareholders' meeting is hereby suspended in the case of a corporation conducting a meeting in accordance with Paragraph AA.1; provided, that the corporation makes the list available on an electronic network to which shareholders are granted access for the entirety of the meeting.
- B. <u>Suspension of inconsistent laws.</u> Any law, order, rule, or regulation inconsistent with this Order is hereby suspended.
- C. <u>Effective date and term.</u> This Order takes effect at 11:59 p.m., Central Time, on February 27, 2021, and shall remain in effect until 11:59 p.m., Central Time, on April 28, 2021.

Dear Chairman Barrett and Members of the State Election Commission,

On behalf of the members of the Williamson County Election Commission, I am writing this letter in regards to the action of our Commission at its meeting on Thursday, December 3, 2020, relative to our Voting Machine vendor, Dominion Voting Systems. The members of the Commission voted unanimously to request that that the State Election Commission reexamine all voting machines provided by Dominion Voting Systems for use in our state in order to ensure that such machines meet the minimum criteria for certification pursuant to T.C.A. § 2-9-117. In order to maintain and ensure confidence in the sanctity of the ballot for the voters of our county, the Commission believes that such an action on your part would be a reasonable measure in response to the scrutiny that Dominion Voting Systems has encountered in the aftermath of the recent November 2020 election. Please be advised that this request is not due in part to any issues that our county has encountered with Dominion Voting Systems or our use of its voting equipment, nor is this a suggestion that our County believes that any of the voting equipment that have been in use in our county since October of 2019 is faulty in any way. However, the Williamson County Election Commission believes that such an action on your part will provide reassurance to our voters that we as election officials have done our due diligence in ensuring that our voting equipment is not only secure but will continue to maintain the highest levels of accuracy in the casting and counting of votes to impart confidence in the system as we move forward.
