INSTRUCTIONS

UCC Financing Statement AMENDMENT Addendum (TN Form UCC3Ad)

Filing Fee: See instructions for UCC Financing Statement AMENDMENT (TN Form UCC3)

Pursuant to T.C.A. § 39-17-117, it is a Class E felony for any person to knowingly prepare, sign, or file any lien or other document with the intent to encumber any real or personal property when such person has no reasonable basis or any legal cause to place such lien or encumbrance on such real or personal property.

A blank form follows these instructions.

The UCC3 Financing Statement Amendment Addendum must be filed in conjunction with a UCC3 Financing Statement Amendment. Please refer to the UCC3 Financing Statement Amendment instructions for directions on how to submit the forms.

Please type or laser-print this form. Be sure it is legible. Read all instructions, especially instruction 13; correct Debtor name is crucial. Follow instructions completely.

Fill in form very carefully; mistakes may have important legal consequences. If you have questions, consult your attorney. Filing office cannot give legal advice.

Do not write in any area of the form other than in the designated application box sections.

11. INITIAL FINANCING STATEMENT FILE NUMBER - Enter information exactly as given in item 1a on the UCC3 Amendment form.

12. NAME OF PARTY AUTHORIZING THIS AMENDMENT - Enter information exactly as given in item 9 on the UCC3 Amendment form.


13. DEBTOR NAME - If the UCC3 Amendment is to be filed or recorded in the real estate records, check box 1b on the UCC3 Amendment. Also, in item 13 of this Amendment Addendum, enter Debtor's name, in proper format exactly identical to the format of item 1 of UCC Financing Statement (UCC1), and enter the name of the record owner in item 16 if Debtor does not have a record interest.

14. COLLATERAL - If space on the UCC3 Amendment form is insufficient or you must provide additional collateral (item 8) information, enter additional information in item 14.

15. If this Financing Statement Amendment covers timber to be cut, as-extracted collateral, or filed as a fixture filing, check the appropriate box in item 15.

16. If Debtor is not a record owner of the described real estate, also provide, in item 16, the name and address of a record owner.

17. IF COLLATERAL IS REAL ESTATE - Provide a full legal description of the real estate in item 17. The description of real estate must be sufficient under the applicable law of the jurisdiction where the real estate is located.
